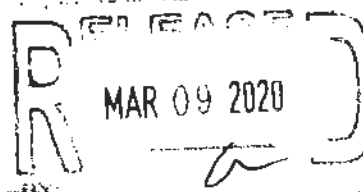

- c. Only the best three (3) posters shall be declared winners as 1st , 2nd , and 3rd based on the following criteria.

Originality	-----	20%
Creativity	-----	20%
Relevance to the theme	-----	40%
Visual Impact	-----	20%
TOTAL	-----	100%


- d. Declared winners shall be given cash prizes in the amount of 6,000.00, 1st 3,000.00, 2nd – 2,000.00 and 3rd – 1,000.00.

- e. Materials to be used shall be provided to the participants such as illustration board (20"x 30"), oil pastel color, pentel pen, pencil and eraser. Participants are given (3) hours to work on their poster.

4. Travel expenses of the participants incident to this activity shall be charged against local funds subject to the usual auditing and accounting procedures.
